- 4. In the event of award of Scholarship/Research Fellowship by the said institute, the eligible post graduate students of our University shall be given preference.
- 5. Recognition is accorded on annual basis and would be subject to renewal on the basis of requisition of the institute by paying the prescribed renewal fee.
- 6. The tenure of recognition and MoU is for a period of four academic years. However, the prescribed renewal fee shall be paid and acknowledgement be obtained within the prescribed period annually.
- 7. Annual Report about the progress of research work of the institute should be submitted every year to the University.
