Your claims for regularisation of Stop Gap Lecturers has
been re-examined in accordance with law laid down by the Hon'ble
Supreme Court of India and Hon'ble High Court of Karnataka. You
are placed in Category III. As there is no need and no vacancy in
your present Institution and there is need and vacancy exists in
PES Science College, Mandya and you have been regularised as
Lecturer in Economics with effect from the date of joining after
today.

2. In case you possess 55% marks in the Master's Degree and
a pass in NET/SLET, your pay will be fixed at the minimum of the
UGC Pay Scale for Lecturer at Rs.2200-4000 + allowances from the
date of regularisation. Otherwise, at present, you will be
fixed, in the minimum of the State Pay Scale for Lecturer at
Rs.2050-3950 + allowances from the date of regularisation.
Meanwhile you will be given an opportunity to acquire the
requisite qualification within three years from the date of your
regularisation.
